

Requirements (continued):

Tagged foods must be properly labeled as required by Wisconsin Food Law, Chapter 97. Labels require a minimum of the following information:
• Name and address of the manufacturer,
• Manufacturer's name and address of the distributor including the zip code.
• A list of ingredients in order of descending predominance, if the item is a food and made from two (2) or more ingredients.
• A statement of the quantity of contents in terms of weight, measure or numerical amount.

It is the responsibility of the vendor to apply and pay for all required licenses or permits required by the City of Oshkosh or the State of Wisconsin under Chapter 75 Wisconsin Administrative Code or Section 29-27 of the Oshkosh Municipal Code. All licenses or permits shall be posted in the vending area in a prominent location.
